### Update

Since our last communication in October 2007, Ka:yu:k't'h'/Che:k'tles7et'h', Toquaht, Uchucklesaht and Ucluelet voted in favour of the Maa-nulth Final Agreement. As you probably already know, each nation has now overwhelmingly approved the Maa-nulth Final Agreement.

Now that all Maa-nulth First Nations have ratified the Final Agreement, British Columbia and then Canada need to ratify the agreement. (As you will see below, BC finalized its process on November 29th and also ratified the agreement). The agreement will now go through ratification process with Canada which is a bit more time-consuming; we'll keep you posted on the progress.



## Introduction Provincial Legislation of Maa-nulth Final Agreement

On November 21st the Maa-nulth Final Agreement Act (Bill 45) was introduced into the Provincial Legislature. Members of all five First Nations attended this historical day. Chief Councillors Charlie Cootes, Vi Mundy, Tess Smith, Robert Dennis and Chief Bert Mack all provided riveting and heartfelt speeches to the Legislature. In addition, the Provincial Government presented the five Maa-nulth First Nations with a red cedar canoe and a paddle carved by Joe and Carl Martin from Tla-o-qui-aht.



“Since the time of contact, our Chiefs and leaders have continuously sought recognition of our rights and title to our homelands and the rightful place of our people therein, and have sought to reach agreement on how we could co-exist within our territories. Together with British Columbians, we move one step closer to the meaning of reconciliation.”

The Maa-nulth Final Agreement was passed in the Provincial Legislature on November 29, 2007. The Bill (45) was given Royal Assent on the same day by the Lieutenant Governor of British Columbia, Steven Point.



## 5th Maa-nulth Annual General Assembly – “*Bringing our Treaty to Life*”

On November 23, 24 and 25, 2007 approximately 250 members from all five Maa-nulth First Nations attended the 5th Maa-nulth Annual General Assembly. The Assembly was held at the Quinsam Hall on the We Wai Kai Traditional Territory in the Campbell River area. This was the largest attended Assembly to date which has left both the members and leaderships optimistic about the positive progress all five nations are making.

“I encourage the youth, all of our children to really listen and pay attention because we need you. We need you to stand, it’s time for you to take over and step in. It’s time for you to do the things that our elders have done and our leaders today have worked so hard at.”

Each Nation will be holding planning meetings to determine how they will get the work done and be fully prepared for the Effective Date.
